



Minutes from October 26, 2023

The El Paso Central Appraisal District Board of Directors held its regular meeting on Thursday, October 26, 2023, at 5:03 p.m., in the Conference Room of the El Paso Central Appraisal District (EPCAD), 5801 Trowbridge Drive, El Paso, Texas, with the following quorum of five members present.

Attorney Carmen Hegeman of Dunbar, Armendariz, Hegeman Law Firm, EPCAD's legal counsel, was in attendance for the entire meeting.

The first order of business was to recite the pledge of allegiance to the flag of the United States of America and the pledge of allegiance to the Texas state flag.

AGENDA ITEM 1 - PUBLIC COMMENT

Mr. David Stone, EPCAD Deputy Chief Appraiser, stated that no one had signed up to make public comment.

<u>ACTION AGENDA ITEM 2 - APPROVAL AND SIGNING OF MINUTES FROM SEPTEMBER 21, 2023 MEETING</u>

Mr. Mena made a motion to approve the September 21, 2023 Minutes as presented; Mr. Coronado seconded; the vote was called and passed.

<u>ACTION AGENDA ITEM 3 - REVIEW AND APPROVAL OF FINANCIAL REPORTS</u> <u>FOR AUGUST 2023</u>

Ms. Rosa Goldmann, EPCAD's Chief Financial Officer, presented the financial report for August 2023. EPCAD's financial reports contain the balance sheet; the report of revenues, expenditures, and changes in cash balance (in actual-to-budget); the investment report; and the notes to the financial report.

The following items were over budget:

- Printing line item by \$5,950.00 due to Appraisal Review Board (ARB) hearing procedure packets and employee business cards.
- Bonding/general insurance line item by \$71.00 due to a new notary.
- ARB line item by \$9,925.00 increase in protests / hearings.

- Taxpayer Liaison Officer expense by \$428.33 due to IAAO 2023 Conference.
- BOD Election Reserve line item by \$527,886.07 due to being encumbered by the board.

The following items are encumbered funds:

- Litigation Reserve balance is \$914,227.82.
- TCDRS Reserve balance is \$329,000.00.
- BOD Election Reserve balance is \$527,886.07.

Ms. Goldmann responded to questions from the board.

Mr. Mena moved to approve the financial reports for August 2023 as presented; Mr. Coronado seconded; the vote was called and passed.

Mr. Berg stated that the financials are approved subject to audit.

<u>ACTION AGENDA ITEM 4 – DISCUSSION AND POSSIBLE ACTION REGARDING THE</u> DECEMBER 2023 BOARD OF DIRECTORS' MEETING

Mr. Berg informed the Board that, historically, the Board does not meet in December. EPCAD meets at least once each quarter, as required.

Mr. Stone requested to cancel the December 2023 Board of Directors' meeting.

Mr. Coronado stated that board members can call a special meeting even if the meeting is cancelled.

Mr. Coronado made a motion to approve the cancellation of the December 2023 board meeting; Mr. Haggerty seconded; the vote was called and approved.

ACTION AGENDA ITEM 5 - DISCUSSION AND POSSIBLE ACTION REGARDING EPCAD'S PROPOSED 2024 HOLIDAY SCHEDULE

Mr. Stone informed the Board that the 2024 proposed holiday schedule has fifteen holidays. The 2023 approved holiday schedule contained fifteen holidays.

Mr. Coronado made a motion to approve the EPCAD 2024 holiday schedule; Mr. Haggerty seconded; the vote was called and approved.

AGENDA ITEM 6 - TAXPAYER LIAISON REPORT

Ms. Tracy Carter, EPCAD Taxpayer Liaison Officer, informed the Board:

• Out of the 34 total applications, received eleven (11) are current ARB members, two (2) are previous ARB members, and twenty-one (21) applicants are new. One applicant

applied for ARB chair, four applied for secretary/deputy secretary. Twenty ARB members need to be appointed.

- Attorney Roy Armstrong provided training to the ARB members on the procedures for the Motion to Correct hearings.
- ARB members were in session October 16 19, 2023, to hear Motion to Correct hearings.
- ARB members and ARB officers will be appointed in November 2023.

With nothing further to report, this concluded Ms. Carter's report.

AGENDA ITEM 7 - CHIEF APPRAISER REPORT

Mr. David Stone, EPCAD Deputy Chief Appraiser, stated that:

- Since August 2023, EPCAD has hosted in-house courses for staff and welcomed staff from regional appraisal districts and local taxing entities.
- On October 10, 2023, EPCAD held a in-house development training. There were four sessions: Emergence Health Network, the El Paso County Sheriff's Department, EPCAD's employment attorney, Ms. Chris Borunda, and speaker Steve Gilliland.
- On October 25, 2023, EPCAD held a wellness fair for employees with 26 vendors exhibiting.
- Anthony Independent School District's tax rate will go down five cents.
- Proposition 4 will increase the homestead tax exemption by raising it from \$40,000 to \$100,000. This proposed change will take effect for the tax year commencing on January 1, 2023.
- Entities need to appoint board members for next year.

Mr. Berg informed the Board that each member had been provided with two sealed packets. One contains information regarding the Chief Appraiser Evaluation and the other the Taxpayer Liaison Officer Evaluation. He requested that the responses be returned to him. Mr. Berg concluded that the evaluations will be presented to the Board at the following Board of Directors meeting during Executive Session.
